







About Us







Responding to the Opioid Crisis

As the rate of opioid misuse and dependence has escalated across communities, a coordinated, multi-system approach is needed to meet the needs of pregnant women with opioid use disorders and their infants and families. These resources will support your collaborative planning and implementation efforts to improve outcomes for families.

Improve collaboration to serve pregnant women with opioid use disorders and their families

A Collaborative Approach to the Treatment of Pregnant Women with Opioid Use Disorders: Practice and Policy Considerations for Child Welfare, Colloborating Medical, and Service Providers - Provides an overview of the extent of opioid use by pregnant women and the effects on the infant. It provides evidence-based recommendations for treatment approaches from leading professional organizations and an in-depth case study. It also offers guidance tools to help facilitate a careful, indepth analysis of a community's current policies, practices, resources, and training needs as related to working with pregnant women with opioid use disorders.



Develop collaborative strategies to support infants with prenatal substance exposure and their families



Screening, Assessment, Referral, and Stitutions, -Recovery Support

Effective screening, assessment, and referral to treatment and recovery supports are critical processes to support family recovery, safety, and stability. These resources will help strengthen a coordinated and cohesive approach to serving families affected by substance use disorders.

Identify strategies for engaging families in

treatment

Screening and Assessment for Family Engagement, Retention and Recovery (SAFERR) - Provides a framework to strengthen screening and assessment practices while building a collaborative team among the child welfare, substance use disorder treatment, and dependency court systems. Appendixes include sample screening and assessment tools.

Drug Testing in Child Welfare: Practice and Policy Considerations - Helps policymakers and program managers incorporate drug testing policies and procedures into their agency's comprehensive family and child welfare assessment protocol. It includes an overview of drug testing methods and a sample drug testing form.

Family-Centered Treatment for Women with Substance Use **Disorders - History, Key Elements, and Challenges - Provides** an introduction to family-centered treatment for women and their families, including treatment modalities and strategies to overcome common barriers.

Navigating the Pathways: Lessons and Promising Practices in Linking Alcohol and Drug Services with Child Welfare (TAP 27, Revised 2015) - Provides an overview of the challenges and opportunities that state and county-level jurisdictions experienced while building collaboration across the child welfare, substance use disorder treatment, and dependency court systems.
