Furthermore, I realize that public assistance records and documents are subject to strict confidentiality requirements imposed by state and federal law, including Wisconsin Statute 49.83.

I certify that I have received training regarding the state and federal laws and University and IRP policies that govern access to and use of confidential information collected by or on behalf of IRP and administrative data collected by federal and state agencies and provided to IRP for research purposes.

I understand that I am being granted access to this information and data based on my agreement to comply with the following terms and conditions: (initial)

I WILL protect the confidentiality of individuals in research data and materials. I understand that all information concerning studied individuals is privileged information and must never be released or reported to any person not immediately involved in the research.

State agencies (data owners) must provide support and approval for any and all uses of data. I understand that access to Wisconsin State administrative data is provided for only the projects on which I am an authorized data user, and that data cannot be used for any other purpose or project.

All data containing personal identifiers remain on the Silo "RD" environment (accessible to IRP programming staff).

I WILL NOT attempt to identify any individuals in IRP data provided for analysis on Silo.

I WILL NOT remove files with individual-level data from the Silo server. Only aggregate information may be removed.

**I WILL prevent others' access to my Silo session** by locking my screen (ctrl+alt+delete) or by logging out of Silo when I temporarily leave my computer.

I WILL NOT share screen images of IRP data on Silo while in a virtual meeting or through photo images or screenshots.

I WILL NOT share any of my passwords that allow access to data, nor will I use these password(s) for other purposes, such as to gain access to an internet site.

I WILL only access IRP confidential data on Silo from non-public locations, such as a campus or home office.

I WILL NOT release any results or analyses using admin data without the prior review of the agencies providing the data. I will provide presentations using administrative data (paper, slides, or poster) to IRP for state agency review at least 30 days prior to the presentation. Any submissions for publication will be provided to IRP at the time of submission, and copies of contracted reports at the time of delivery to grantor.
